#### Statutorily Authorized Fee Increase

- According to 2010 Federal Census, Kane County now has a population over 500,000
- Under 500,000, fees are governed by 705 ILCS 105/27.1a
- Over 500,000, fees are governed by 705 ILCS 105/27.2
  - o "The fees of the clerks of the circuit court in all counties having a population in excess of 500,000 inhabitants but less than 3,000,000 inhabitants in the instances described in this Section shall be as provided in this Section. In those instances where a minimum and maximum fee is stated, counties with more than 500,000 inhabitants but less than 3,000,000 inhabitants must charge the minimum fee listed in this Section and may charge up to the maximum fee if the county board has by resolution increased the fee." 705 ILCS 105/27.2.

 Judiciary as a whole is comprised of several departments, all of which are impacted by court fees




 Salaries have remained stagnant, despite increases in the consumer price index (CPI)




### Current Salary Levels in Relation to CPI: Court Services




## Current Salary Levels in Relation to CPI: Judiciary




## Current Salary Levels in Relation to CPI: State's Attorney




## Current Salary Levels in Relation to CPI: Public Defender

## Current Funding State of the Judiciary

- Disparity between Kane County judiciary salaries and judiciary salaries of neighboring counties of similar size
  - Article published by The Courier-News, August 2, 2011, indicated that there has been a trend over the last couple of years with assistant state's attorneys receiving their training and experience in Kane County, then leaving to accept opportunities for more money in neighboring counties
  - Article indicated that starting salary for Kane County assistant state's attorney is \$40,000, compared to \$51,600 in McHenry, \$54,100 in DuPage, \$53,700 in Lake, and \$51,600 in Will







- Kane County to receive four new judges
  - Implications of additional Judges:
    - Technology
    - Physical Space
    - Additional Staff
- Need for new Case Management System
  - Estimated to cost \$5-12 million, according to preliminary numbers from County's URL study

#### Potential Revenue

Based on the number of filings in 2010, an increase in fees could yield...

\$1,144,611.00 in revenue

The number of future filings is expected to increase from the 2010 numbers, thereby generating additional revenue

#### County Board Authority

Board resolution is required in order to authorize fee increase.

"[C]ounties with more than 500,000 inhabitants but less than 3,000,000 inhabitants must charge the minimum fee...and may charge up to the maximum fee if the county board has by resolution increased the fee." 705 ILCS 105/27.2.
