Requirements Prior to Demolition

The applicant is required to comply with all Federal and State laws and standards for the proper identification and disposal of waste and hazardous materials.

All demolition work shall meet the requirements set forth in Article 3_ Erosion and Sediment Control contained in the Kane County Stormwater Ordinance. If demolition will disturb an area greater than 5,000 sq. ft. A Kane County Stormwater Permit will be required. Existing drainage patterns shall be maintained during demolition. Drainage easements and overland flow paths shall be kept clear of debris. Post-demolition grading shall provide positive drainage on the site and maintain pre-demolition drainage patterns.

Final Inspection and Approval

The owner or applicant shall notify the County Inspector when restoration work has been completed, in order that the project site may be inspected and approved. Prior to scheduling final inspection, documentation of all other related permit approvals must be provided to the Building Division.
